### IV. REGULAR CALENDAR

A. Risk Assessment Report for the Plan year ended December 31, 2022 – Presentation by Segal Consulting

Actuaries Paul Angelo and Andy Yeung of Segal Consulting discussed the change in Actuarial Standards of Practice that suggested a standalone Risk Assessment Report that now contains a quantitative analysis of several potential risk factors, including projections demonstrating investment returns above and below the actuarially assumed investment rate of return. Trustees discussed current inflation factors and forward projections and Mr. Angelo explained the inputs Segal considers when recommending an inflation assumption, which include Social Security cost of living projections, Consumer Price Index projections and U. S. Treasury bond yields.

**Recommendation**: Accept the Risk Assessment Report for the plan year ended December 31, 2022.

B. Low-Default-Risk Obligation Measure (LDROM) Educational Presentation – Segal Consulting

Mr. Angelo explained Actuarial Standards of Practice 4 (ASOP 4) which was updated to include three new requirements for public defined benefit plan actuarial reporting that consist of a disclosure explaining the implications of a plan's Actuarial Funding Policy, disclosure of a reasonable Actuarially Determined Contribution and calculation and disclosure of a Low Default Risk Obligation Measure. ASOP 4 further states that a plan

could continue to measure plan liability and set contribution requirements using the level cost method and the plan's expected investment return and other assumptions and that the Low Default Risk Obligation Measure was a reporting requirement, not a funding requirement.
