The Board unanimously granted the application of Darin Dougherty, Sheriff's Captain, for a service connected disability retirement.

  - 1. Resolution #166 Authorizing Adoption of Employee and Employer Contribution Rates for FY 2024/2025 for the County of Sonoma.

Ms. Hess presented the fiscal year 2024/25 contribution rates and explained that the rates were from the December 31, 2022, actuarial valuation that the Board approved in May of 2023. Additionally, SCERA has instituted a new procedure of having our actuary review the rate packets and contribution rates before presenting them to the Board. This was successfully done this year and SCERA staff feel confident that this extra step ensures accuracy of the contribution rates. Ms. Enold explained how the rates are reduced to account for County paid benefits above Internal Revenue Code section 415 limitations This section limits the amount of retirement benefits that can be paid from a defined benefit public pension plan. Additionally, she explained how the sunset of additional employee contributions increased employer contribution rates for some classes. The sunsetting rates were a product of negotiations between the County of Sonoma and Labor.

Ms. Enold explained that our December 31, 2023, Actuarial Valuation will be presented at the May 2, 2024, Board meeting and that the Annual Comprehensive Financial Report (ACFR) will be presented at the June 20, 2024, Board meeting.

Ms. Hess informed the Board that SCERA staff applied for a grant to provide financial assistance with the fence and gate project. SCERA was awarded the grant and will soon be receiving it.
